#### Our Mission:

First Unitarian Portland is a beacon of hope for us and for our community, a spiritual center in the heart of our city that helps each of us to find our moral compass, calling and challenging us to build the beloved community with an ever deepening sense of spirit, diversity and inclusion.

#### **Goals for First Unitarian Church**

<u>Five Year Church Goals</u> are created in collaboration with the congregation and Executive Team and adopted by the Board. They reflect the mission and vision of our church. Church goals are primarily carried out by the Executive Team and staff, collaborating with the Board.

Board 1-3 Year Goals are created by the Board and Executive Team at our yearly Retreat. Board goals may draw from the 5 Year Church goals, yet reflect work within the purview of the Board.

#### **First Unitarian Church Five Year Goals**

- Develop a long-term plan for development and sustainability of church campus given changing dynamics of West End and downtown Portland.

- 1. Continued to work on issues of Power, Privilege and White Supremacy Culture by
  - a. Educating ourselves on the issues.
  - b. Examining the ways in which Power, Privilege and White Supremacy Culture affect our Church, including our Board work.
  - c. Taking steps to improve our practices.
- 2. Support Executive Team to have an Annual Fund Drive and other income streams that meet the church's budgeted expenses by the 2020-2021 church year
- 3. Governance committee to review and possibly recommend changes to the bylaws as they relate to size of Board, and definition of pledging member in by-laws and policies.
- 4. Ensure that current possibilities for development on the current campus receive thoughtful consideration and appropriate Board review.
- 5. Continue a Senior Minister Transition Team to educate the Board, create a timeline, and a congregation education plan.

Agenda was reviewed. Theo brought up a concern voiced by a congregant in a wheelchair that he would like to have the option to sit on the main floor of the sanctuary, rather than in the gallery where people in wheelchairs generally sit. Ryan shared that he and Kathryn would be meeting with the congregant to talk about his concerns. No discussion item was added to the agenda.

# Review and Approve previous meeting's minutes:

Ryan Deibert moved, and Leila Wrathall seconded a motion to approve the minutes. The motion carried with a unanimous vote.

# **ET updates**

- AFD
  - There is cause for celebration: 1) there was an increase in the total dollar amount of pledges, 2) the average pledge increased slightly, and 3) the average pledge of new members is higher than usual.
  - There is also still work to be done: we only saw an increase of 2% in the total pledge amount over last year against a goal of a 10%.
- Budget
  - We will budget within the resources we have available.
  - Budget development is a two-step process: 1) The first rough budget, which represents what programs are asking for, is not expected to be balanced, 2) the second budget submission to the Finance Committee will be balanced.
- The circumstances of our financial resources mean we will not be able to hire a third minister in the next church year; for the foreseeable future, this likely will be a two-minister church. The pastoral load on the ministers continues to be very high.
- The proceeds from this year's auction will go to fund Phase 0 work on the block development project. The theme of the auction is "Designing for the Future." Phase 0 work has begun.
- UUA Certification
  - Members 958 (982 last year)
  - Average Sunday attendance 802 (900 last year)
  - Average Sunday RE attendance 381 (376 last year)
  - Number of pledges 910 (966 last year)
- Trends in membership and attendance
  - 15% decrease in membership over the last five years. We are doing better than all but two of the other large churches in the UUA. We outperform like institutions, but there is still a decline.
  - Less frequent attendance has become more the norm. This is a cultural trend.
  - The number of pledgers is down 8% over the last five years, but we lead the UUA in number of pledgers.
  - Our ministry is more robust than other large churches.
  - In calendar 2019, we lost 136 members to death or inactivation and we added 41 new members. In years past, we averaged 60-100 new members per year.
  - RE attendance is down more significantly than adult attendance over the last five years 199 vs. 165. Kids are busier than in the past and going to church has become optional in many families.
  - The reset of the choirs has resulted in the average number of singers each week dropping from 51 to 31. Many of the choir members who have dropped out came to church mostly to sing and were not as involved in other church activities and programs.
  - Other less easily quantifiable factors that might be contributing to the decrease in attendance were discussed.
- Ministry is well into the planning process for the next church year.

- We will have an intern minister next year, Stacey Mitchell. We will have fewer guest preachers.
- All money will be out of the Wells Fargo accounts by the end of the month.
- The financial review is taking longer than in the past. The new accountants are being more thorough.
- Emergency planning is underway.
  - Planning for an immediate emergency, headed by Marilyn Eichinger.
  - Planning for continuity of operations what do we need to have in place to carry on during an emergency, headed by Terry Martin.

Committee Reports are included in the board packet and included here by reference.

# **Consent Agenda:**

- Approve Moderator Mindy Clark and Secretary Ryan Deibert for 2020-2021 church year.
- Agree to Gov Comm recommendation to skip a congregational survey this church year and work with Search Comm to include essential questions board might have (see Gov Comm minutes attached for explanation).
- Approve recommendations from Fin Comm meeting (see minutes attached for explanation): That staff are
  authorized to combine multiple restricted accounts into combined restricted bank accounts and multiple
  reserved accounts into combined reserved accounts as long as the specified restricted and reserve
  accounts are accounted for separately in the church's books.

Combine Major Donor Reserve, Special Projects Reserve and Required Loan Reserve Funds. New name, purpose, authority, etc. to be determined.

Leila Wrathall moved and Brad Taylor seconded a motion to approve the consent agenda. The motion passed with a unanimous vote.

#### **Action Items:**

- First Connections/Board Greeting changes:
   Ministry has decided to revise the board greeter and First Connections activities. Rather than asking visitors to meet in the Channing Room for First Connections, the meeting will now take place in the north gallery of the sanctuary after the service. The board member signed up to greet will join the group.
- Discuss and agree on process to evaluate and select Search Committee members. Use document drafted by Cindy.
  - Bill Sinkford left the meeting at 8:18. The board began the discussion.
  - We have received 47 applications for the Search Committee (SC). Four of them were from people who
    are not voting members and Nom Comm will notify them that they are not eligible.
  - The board will meet with Nom Comm on 2/22/20 to hear from them the results of their evaluation of the applications. The meeting will be from 10:00-12:00.
  - The board will meet on 3/1/20 from 10:30-4:30 to select the 7-9 members of the SC. Alan suggested that process observation be used in the meeting.

- Cindy reviewed the process that was used in the 2009 SC selection. Questions were asked and answered.
- It was suggested that the charge to the SC include a recommendation to use process observation in their meetings.

# **Communication Check:**

- Com Comm will discuss how the announcement of the SC will be made to the congregation.
- Com Comm will look at a new date for the previously scheduled April board forum.

#### **Process Observations:**

- During the conversation on membership:
  - People queued up to speak and respected the order of comment.
  - The discussion stayed on topic (addressing the issue).
  - Space was held for all comments and perspectives.
  - During the conversation on the SC selection process:
    - This was a somewhat more tense conversation.
    - People looked to the document on the process and worked to clarify their understanding of it.

Closing Words: Barbara read a poem by Robert Hayden, "Those Winter Sundays."

# Governance Committee Meeting – February 2, 2020, 7-8pm Meeting Notes

Attending: Cindy Cumfer, Ryan Deibert, Andy Parker, Mindy Clark, Kathy Ludlow Minutes by Cindy Cumfer

Minutes from the January meeting were approved.

# To Do:

Kathy agrees that the BOC will consider all amendments to the Articles and Bylaws and the revised Board policies at its February meeting.

Cindy and Ryan will draft explanations for the changes to the Articles and Bylaws (before the February BOC meeting).

Ryan will draft a proposed Board Self-Evaluation and provide it to Gov Comm by our March meeting. Cindy will check with the ET about dates to meet with them in connection with our Assessment of the Ministry of the church in June.

#### **DECISIONS:**

- 1. GC agreed to send Board Policy Manual with proposed revisions to BOC and recommendations on Articles/bylaws changes, including the Amendment to the Restated Articles to remove the word "the" from the church name, to BOC. Kathy agreed that the BOC will consider this at its February meeting to send to the Board for its March meeting. The safe church policy will be considered later, probably next year.
- 2. Congregational survey. GC is open to doing a congregational survey next year, as it is Bill's final year. It was suggested that we might want to do one after the new minister completes their first year, as well.
- 3. Assessment of the Ministry: We threw out a number of ideas about the Assessment:
  - GC is interested in getting comparative data about the decline in UU churches in the last several years.
  - The Assessment needs to acknowledge the strains faced by the ministers in operating without an intern minister.
  - GC is interested in following up on the email exchange between Bill and Cindy about focusing attention on what the church has done well and how to build on this and not just focus on our challenges.
  - We noted that Bill identified our governance system that avoids tying up the ministry in its day-to-day functioning as a strength and one not shared by many larger congregations.
  - We should thread back to our congregational survey of last year for congregant info and to identify strengths Bill may not have mentioned.
  - We raised the question about whether a decline in members/insufficient pledges should only be considered as a negative. What can we imagine that might be fruitful about a smaller congregation? Might it enrich the spiritual life of the church?
  - The Board should consider taking the opportunity to provoke a congregational discussion about UU decline nationally, and ours.
- 4. Work Schedule: The Committee created the following schedule for the remainder of its work this year:

February BOC mtg: BOC will pass on all amendment to Articles, bylaws, and board policies for vote at the March board meeting. Cindy and Ryan will draft explanations for these changes before this meeting.

March GC meeting: Review Board self-eval and construct our model for this year

- Question about whether Moderator should be a member of/expected to attend all Committee meetings
- Get model out so that we have results by April meeting

Review of safe church policy: when and what? Preliminary discussion of assessment of ministry

April GC meeting: Summarize results of Board self-eval for May Board meeting

Construct assessment of ministry

April 19 is the date of the congregational forum. We should talk with Comm Comm about whether some of the forum can/will be devoted to input on ministerial assessment or other Gov Comm matters.

May Board meeting: conduct part of Board meeting on Board Self-Evaluation

May GC meeting: finalize committee draft of assessment of ministry

<sup>\*</sup>Budget YTD is an estimate of amount of income received and expenditures that are projected for this point in time. The amount varies by month, e.g. pledge income is consistently lower in summer.

**Discussion: January Financial Report:** Kathryn prepared a monthly operating summary that shows January 2019/December 2018 so we could see how the church's current finances are doing relative to last year. Pledge income is lower than December but up compared to last year. The year to date is ahead of the projected budget year to date. Net cash effect is positive for the second month in a row. Looking at the Attendance stats on Dashboard, average attendance per Sunday year to date this fiscal year is down by 10.06% compared to the prior fiscal year. This is something we'll have to continue to monitor.

Payroll expenses are higher than last year's due to the negotiated union increases and cost of living for non-union staff except ET. Sextons now are receiving \$17.50 an hour, same as office positions. However, in the future increases will be tied to the church's overall income. The ET are not receiving any increases this year.

# <u>Updates – Kathryn</u>

<u>Annual Fund Drive:</u> Continuing to track closely to last year's figures. As of this meeting, there are have 872 donors, at 91.5% of goal.

<u>Buchan Sprinkler Damage:</u> Significantly less damage this time. Turned off water much more quickly which limited damage. The sprinkler went off when a sexton was in the building and they knew immediately what to do this time. Kathryn is talking to insurance company about the situation and working on how to assess the systems issues.

<u>Budget:</u> Kathryn reviewed the initial budget draft with the committee. As mentioned above, payroll has increased; health insurance has increased but not significantly. No reserve income was included in this budget, but look at that if needed as they work on the budget.

<u>Capitalization & Fixed Asset Policy:</u> Not enough time to discuss, will bring it back later. Some input that fixed asset and capitalization should be split.

Ed agreed to do open and closing reading next meeting.

# ARTICLES/BYLAWS CHANGES RECOMMENDED BY GOVERNANCE COMMITTEE AND EXPLANATIONS

The Governance Committee recommends that the Board of Directors adopt, submit to and recommend to the voting members of the church the adoption of the following amendments to the church's:

# Restated Articles of Incorporation.

# 1. Amend Article 1 of the Articles of Amendment filed July 12, 1999 as follows:

Change the name of the church from "The First Unitarian Church of Portland, Oregon" to "First Unitarian Church of Portland, Oregon."

**EXPLANATION**: The Executive Team requested this amendment. Donors and others interested in the church typically search for our name in the state website and other databases under "First Unitarian Church." Oregon's Secretary of State and other governmental offices use our official name "The First Unitarian Church of Portland, Oregon." Searchers for "First Unitarian Church" are told that there is no such entity registered. The church has been told that the use of "The" throws off the search.

#### 2. Amend Article IV, Section 2, as follows:

"The Board of Trustees may vary actual expenditures from budgeted amounts insofar as actual income varies from budgeted income. However, any authorization by the Board of Trustees for sale or mortgage of real property, or for any single unbudgeted expenditure of more than \$20,000 from non-restricted funds-shall be effective only if approved or ratified by a vote of two-thirds of the members present and voting at an annual or special meeting. Any single unbudgeted expenditure from non-restricted funds of 2% or more of the Church's Total Adopted Budget must have prior approval of the Board of Trustees."

**EXPLANATION**: The Governance Committee contacted the Finance Committee to see if this provision needed to be updated, preferably in a way that made it less likely to go out of date. The Finance Committee

responded that it did need to be amended and proposed this Amendment, which ties variance requiring membership approval to a percentage of the budget, rather than a flat dollar sum.

The Governance Committee recommends that the Board adopt and submit to and recommend to the voting members of the church the adoption of the following amendments to the church's:

# **Bylaws**:

# 1. Amendment to Voting Membership Provision in the Bylaws, Article II, Section 2:

"Voting Membership defined. A member who is at least 16 years of age and has, during the preceding 12 monthscalendar year, contributed a minimum amount established from time to time by Governing Policies is a voting member of this church."

**EXPLANATION:** Kathryn Estey reviewed with the Governance Committee a number of issues that the Executive Team has in interpreting Article II, Section 2. The church needs to know who its voting members are at the time of each election. The bylaws phrase "during the preceding 12 months" is not easily ascertainable from the church records at the time the ET prepares for the annual election, generally in April, since members tend to pledge based on a calendar year. Kathryn proposed and the Committee agreed to recommend a change to the bylaws that this provision would read "during the preceding calendar year," which corresponds to the pledge year used by most members.

# 2. Amendment to Vacancies in the Bylaws, Article IV, Section 2.

"A vacancy in the Board of Trustees shall may be filled by election by the remaining trustees until the next annual meeting, at which time a successor shall be elected for the balance of the unexpired term."

**EXPLANATION:** The Board generally prefers to fill vacancies as they occur but requests the flexibility to choose to fill or not fill a vacancy during the remainder of the church year, depending on the circumstances. The Board takes the orientation of its new members under our system of policy-based governance seriously. In addition, church business may be especially complicated some years. Some vacancies occur near the end of the church year, and the Board may prefer not to put time and energy into orienting a new Board member who may serve a very short term. In some years, Board business is particularly complicated and it may take considerable time to orient a new member. If the Board is unusually busy, it may prefer to orient all new members the next church year. The Governance Committee recommends that the Board be given this flexibility.

# 3. Elimination of the Ministerial Relations Committee in the Bylaws, Article VIII, Section 3.

# "Section 3. Ministerial Relations Committees.

- (a) A Ministerial Relations Committee shall be established for each minister called by the congregation. Membership of a committee shall consist of five voting members of the congregation nominated by the minister and appointed by the Board of Trustees. Members serve for a term of three years.
- (b) The committee shall serve as a conduit between the minister and the congregation regarding issues of concern.
- (c) The committee shall be available to the minister for advice and counsel.
- (d) The chairperson of a committee shall advise the Moderator in the event the committee has a serious concern about the minister's ability to perform the minister's functions properly."

The Committee recommends to the Board that the Board request the members to eliminate the provision in the Bylaws requiring a Ministerial Relations Committee.

**EXPLANATION:** The Governance Committee recommends to the Board that this provision be eliminated. Each minister does form a Ministerial Relations Committee that acts as a sounding board and support system for the ministers, but it has been many years since these Committees have been appointed by the Board. The dynamics of large church governance and the advent of modern communications like email and electronic church newsletters replace whatever "governance" role Ministerial Relations Committees previously filled. Congregants can easily contact our ministers by email, if they want to voice concerns directly to the minister. Congregants are also free to contact the Board with their concerns. The Bylaws are a document that describes Board governance, and Ministerial Relations Committees, while serving a valuable role as a sounding board and support for ministers, are no longer a part of the church governance system.
