- 2. Holding the mission of the church, engage in ongoing, generative conversations with the Executive Team and the congregation to:
 - a) Develop an understanding of the post-pandemic church that's emerging, as well as the pastoral needs and continuing connections among congregants.
 - b) Approve a revenue plan to sustain the mission of the church during this evolving period.
 - c) Consider viable options for maintenance of our current physical plant and future development of the campus as is feasible.
- 3. Continue to support the Ministerial Search Committee and the transition to a new Senior Minister.
- 4. Develop and nurture a covenantal relationship with the new Senior Minister.
- 5. Consider the appropriate size for the board and, if a change is decided upon, refer a recommendation to the congregation for a vote.

Finance Committee Meeting

March 14, 2023

Check-Ins

Approval of February meeting minutes

Review vs. Audit Discussion

Kathryn: with staff transitions and move to SMJ the audit firm recommended that we have another year of review, and not an audit. Church policies call for "an audit or review" every three years. Linda: do not count on our ability to get an audit next year, there are not enough CPAs to go around and we are small, yet complicated, so less appealing as clients. We need to prepare our financials to allow for an audit, and with our transition with SMJ it is too early. Our last audit was 5 years ago. Finance Comm needs to keep this on our radar.

Alison: internal vs. external audit? Internal audit may be a possibility, especially if we can recruit congregants with appropriate skills to serve as volunteers.

Committee voted unanimously in favor of moving forward with a review. This question now goes to the full Board for ratification. Assuming the Board approves, an explanation of the review process will be included in the information we give to congregants.

ET Update

Erin reviewed the 2022 Campaign Performances. 750 donors, we have reached 94.42% of our goal, \$87k less than our goal.

2023 Campaign, 705 donors, 86% of the goal, \$220k less than goal. This does not include amounts from the Close the Gap campaign, which may be at around \$50k now.

The ET recognizes the lower number of pledging units and will take that into consideration when looking organizationally and at the staffing.

January Financials

Income highlights:

Pledges, non-pledge contributions are on track, plate contributions are quite a bit higher than expected.

Plate passing has started again. We will need to wait to see if this will increase the giving.

Expenses highlights:

Many line items are over, many are under, but the overall this is within budget.

Discussion on whether we can rely on last year's numbers as reported by SMJ to properly budget for next year. Andy asks that the accounting advisory team provides counsel on the matter.

Given the current banking crisis with mid-level banks, it was requested that Kathryn ask our bank for reassurances of their solvency. She and Andy will pursue this. Linda brought up the \$250,000 FDIC limit and we need to pay attention to this.
